### 7. Special Resolutions

- a) "That the association be wound up voluntarily by way of a members' voluntary winding up and that John McInerney of Grant Thornton Australia Limited be appointed Liquidator of the association pursuant to the provisions of sections 62 and 64 of the Associations Incorporations Act 2009."

- b) "That the members direct the Liquidator to apply to the Secretary of the Department of Fair Trading when appropriate or upon finalisation of the liquidation for consent to destroy books within the retention period in accordance with IPS 70-35."
- c) "That the secretary includes the Remuneration Approval Report with the members' resolution."
